- Participants must provide your own:
 - 10X10 canopy with weights
 - Table & table covering
 - **Signage** and/or banners that clearly identify the group in large print
 - Groups arriving without proper signage will not be permitted to set-up
- **Participants must be set up by 9 am and remain setup until 1 pm, No Exceptions**
- No product may be sold that is available at the market
 - Businesses may offer free activities: i.e., face painting, caricatures, games, contests
 - Organizations may offer activities, sell tickets or limited products
- Participants are strongly encouraged to display materials in a tasteful, eye-catching manner
- No blocking walkways or mailboxes or parking in the circle
- No music or amplified sound unless approved in advance
- No smoking, drinking or pets unless approved in advance
- No unsupervised children under age 18
- No soliciting existing market vendors
- In the event there are vending spaces open in the market, groups may not occupy those spaces
- Please clean your space at the end of the market
